Home Visitation Contracts:

ED met with all grantees and have provided a Contract Renewal Application to grantees. This will give grantees to articulate what services they would like to provide, how they would will measurable outcomes, and what data system they will use. The First 5 Plumas data system is available but required model programs (e.g. Parents As Teachers) may have data collection requirements and we want to provide flexibility to the programs. First 5 Plumas will provide technical assistance to the programs.

ASQ/Help Me Grow Planning:

First 5 Plumas trained 9 service providers on the ASQ Online. We have also promoted ASQ Online and Imagination Library on flyers distributed at 20,000 Lives, the High Sierra Parent Conference, and through the First 5 Plumas newsletter.
